## **Matters Arising**

David DeLapp proposed "The Classic and Enthusiasts Motorcycle Club of NSW inc. cancel it's affiliation with Motorcycling NSW due to the prescriptive and onerous nature of the rules of affiliation and that the workings of MNSW are aimed at competition clubs and do not match the social workings of our club". Seconded by Konrad Dover. Voted on and passed unanimously by members present. Alan Harper to notify Motorcycling NSW of the club's intention to withdraw our affiliation.

Ian Wood raised to issue of Directors and Officers insurance held with CGU and that this is now redundant as it is covered under new policy though GJ Gallagher. Discussed and Peter Boros raised motion to cancel the CGU insurance and request refund. Seconded Ian Wood. Voted on and passed unanimously by members present. Alan Harper to organize.
